Sir,

This is in continuation of DGET letter of even number dated 08.10.2014 regarding Re- verification of ITIs, accredited by QCI.

In this context, it is informed that a revised list of ITIs (*as per Computerized Random Process*) and revised DGE&T institutes based upon distances have been prepared and enclosed herewith for conducting Re- verification of ITIs which are accredited by QCI. Revised list of 5% ITIs has been prepared out of total ITIs accredited by QCI.

The verifying officers will be making observation on training infrastructure, trainers, training, etc. but they will not recommend for affiliation/de-affiliation. The observation of verifying officers should be supported by videography.

You are, therefore, requested to depute one officer as per revised list preferably not below the rank of ADT in coordination with respective state for conducting Re-verification of ITIs (list enclosed) considering the following 3 points and send the inspection report.

1. ITIs for any particular state which have been completely covered & Re-verified by officers in compliance of the DGET earlier letter dt.08.10.2014 may be treated as verified.
2. Institutes for any particular state where in- partial nos of ITIs have been re verified by officers in compliance of the DGET letter dt 08.10.2014, may be accepted as verified but in addition as per revised list remaining nos of ITIs may be selected on random basis by DGE&T Institutes and same be re-verified.
3. ITIs for any particular state which have not been Re-verified by officers in compliance of the DGET earlier letter dt.08.10.2014 will be re-verified as per revised list.

In case of any doubt, clarification may be sought.


