ADMISSION NOTICE OF APPRENTICESHIP TRAINING SCHEME

Establishment/Employers of Government and Public Sector undertakings and Private Industries, (which include Punjab State Boards, Corporations, Municipal Corporations, Municipal Committees) whose occupations falls under the schedule of Designated Trades of Apprentice Act, 1961, are liable to engage apprentices according to prescribed norms. Establishments can advertise the vacancies in the local, regional newspapers, electronic media and approach local employment exchanges, nearby industrial training institutes for admission.

To encourage more MSMEs to engage Apprentice a new scheme National Apprenticeship Promotion Scheme has also been started from 01.09.2016. This Scheme supports other establishments covered under the Apprentices Act, 1961 by reimbursing 25% of prescribed stipend subject to a maximum of Rs. 1500/- per month per apprentice to the employers. The stipend support would not be given during the basic training period for fresher apprentices. Reimbursement of basic training cost in respect of apprentices who come directly to apprenticeship training without any formal trade training in ITIs, will be limited to Rs. 7500/- for a maximum of 500 hours/3 months. A public web portal of MIS application www.apprenticeshipindia.gov.in has been designed by DGT, Govt. of India to engage the apprentices and to allow timely and transparent flow of information. All the Establishments (Punjab State Boards, Corporations, and Municipal Corporations/Committees) are liable to be registered on Portal. Detailed Instructions and Guidelines are available on the portal.

For Registration throughout the year, interested candidates (8th/10th/12th pass and NTC holders) can use following Modes:-

- 1. Register themselves on the portal www.apprenticeshipindia.gov.in and approach the establishments selected by them for engaging them
- 2. Send the filled Registration proforma along with scanned copies of Documents on email ID:-app.regsitration@gmail.com
- 3. Submit filled prescribed proforma along with copies of documents for registration on portal in any Govt. I.T.I. of Punjab State.

Candidates who register and their contracts are generated on or before 15th April, will be allocated to the first batch of that year and those who register after this date but on or before 15th October will be allocated to to the second batch of that year.

Format of Prescribed proforma is available on the web site: www.punjabitis.gov.in List of Designated Trades of DGT, Govt. of India, details of registered Establishments along with their assessed seats & trades and eligibility qualifications are available on the DGT portal. Seats available in the registered Establishments are filled on merit but first cum first serve basis.
